Press Release is an official document written and prepared by a communication or public relations department to give out an announcement from a respective organization. Press Release is also called **News Release** is the backbone of publicizing an organization to the public. A press release is preferably written on a single page however if the information is too long then it can exceed to two pages and not more than that.



# PRESS RELEASE

Primary reason of writing press release is help to achieve organizational objectives. News releases form a basis of stories in news column of newspapers and magazines publicized on a radio or TV programme and now a days social media. Press releases tend to create awareness and that creates a public attention about an issue, situation, products and services concerning an organization.

Publicity releases take many forms depending on the audience and the medium for which they are intended. A publicity press release should focus on one topic only conform to accepted journalistic style and begin with a self sufficient lead paragraph.

# PRESS RELEASE

**Name Of The Organization** has to be included on the document to show recognition and specification of where the information is originating from.

**Logo** this is to show the brand responsible for the press statement, this is for recognition too.

**Headline** it's a brief sentence that aims at giving a journalist an indication of what the release is about, gives the bottom-line the newsworthy aspect of the story.

**Location** acknowledging where the information was written, where the organization resides is very important.

**Contacts** involves the organization available contacts such as the email address, fax and telephone numbers and website.

**Date** notify when exactly the press was released.



# PRESS RELEASE

**Address**, describes the organization's location involving the post office box, the name of an area, street, city or region.

The term "**PRESS RELEASE**" should be written down on the document as it differentiates the document from all other document.

**Name, signature** and **position** of the writer ensures the originality of the announcement and shows that the information is from a credible source of the organization.





# PRESS RELEASE

**Lead Paragraph**, the most important part of the press, provides the basic details of the story. Use the inverted pyramid style of writing, emphasizing the important or interesting facts first in the story. Here the story is written in inverted pyramids form where the 5 W's are well described. Explaining What is it about?, Who is it about?, Where is it taking place?, When is it taking place?, Why is the reason? And How is it going to happen?

**Main Body** is the part that provides more details and info of an issue, event or a product. Usually explains extra information for more clarification.

**Conclusion** is the ending part that includes an apology to a troubling issue and a thank you to the public for support and to the organization.





# IMPORTANCE OF WRITING A PRESS RELEASE

- Press release is a source of news story ideas as they announce on appointments, promotions, events, press conferences etc.
- Press releases are cost effective, they are distributed at a nominal cost compared to press conference and advertising.
- Factor of credibility, studies show that people consider information in a news story to be much believable than an advertisement. It's a believable statement than adverts.
- A press statement provides clarification on a bad story, wrong and fake news, rumors, gossip or a negative situation diminishing the organization's image. This is a way to bury bad news story by giving out facts and confronting the issue plus apologizing to the public. Press release prevents harms and negative image of an organization.
- Press release announce important information to the public, can be an event, product launching, Press release provide exclusive announcements to the public and media houses.
- Press release show where the organization stands on certain decision making and shares respective apologies to the public.

Press release promotes a brand and strengthen the image of an organization.

**STATEMENT BY AMBASSADOR DONALD WRIGHT**  
**ON THE PASSING OF ZANZIBAR FIRST VICE PRESIDENT SEIF SHARIF HAMAD**  
FEBRUARY 18, 2021

Yesterday Tanzania lost one of its giants. On behalf of President Biden, the U.S. government, and the American people, I offer my deepest condolences to all Tanzanians on the passing of the First Vice President of Zanzibar, Seif Sharif Hamad.

Seif was known to all as "Maalim," the Kiswahili honorific meaning "teacher." It was a fitting title for, indeed, he had much to teach us.

Maalim Seif never wanted to be a politician, yet he spent over 40 years in politics. He was chosen by others to lead because of his immense gifts: his compassion, his wisdom, and his strength of character. The story goes that he was drafted into government out of high school, after being asked to fill a vacancy in the civil service by the new Zanzibar Revolutionary Government. This pattern repeated throughout his decades of service to the people of Zanzibar, including his career's final chapter, when President Mwinyi asked him to join in a Government of National Unity as Zanzibar's First Vice President.

The Fund has received information relating to a recent contribution by an anonymous individual to the Inspector General of Government (IGG). The report contains a number of unsubstantiated allegations against the Fund, which have later been reported to the media today.

The Fund is open to any investigation by the IGG. We will provide the required information to enable the IGG carry out investigations.
